Decision and Order Affirming the Determination of the Douglas County Board of Equalization

Background

- 1. The Subject Property is a residential parcel improved with a 2,820 square foot two story residence, with a legal description of: Shadow View 2nd add Lot 34 Block 0 Irreg, Douglas County, Nebraska.
- 2. The Douglas County Assessor (the County Assessor) assessed the Subject Property at \$363,000 for tax year 2017.
- 3. Eyad Skaf (the Taxpayer) protested this value to the Douglas County Board of Equalization (the County Board) and requested an assessed value of \$342,700 for tax year 2017.
- 4. The County Board determined that the taxable value of the Subject Property was \$363,000 for tax year 2017.
- 5. The Taxpayer appealed the determination of the County Board to the Tax Equalization and Review Commission (the Commission).
- 6. A Single Commissioner hearing was held on August 22, 2019, at Omaha State Office Building, 1313 Farnam, Room 227, Omaha, Nebraska before Commissioner Steven Keetle.
- 7. Jason Rich was present at the hearing for the Taxpayer.
- 8. Larry Thomsen, Senior Appraiser: Residential, of the Douglas County Assessor/Register of Deeds Office (the County Appraiser) was present for the County Board.

Applicable Law

- 9. All real property in Nebraska subject to taxation shall be assessed as of the effective date of January 1.¹
- 10. The Commission's review of the determination of the County Board of Equalization is de novo.²

- 11. When considering an appeal a presumption exists that the "board of equalization has faithfully performed its official duties in making an assessment and has acted upon sufficient competent evidence to justify its action." That presumption "remains until there is competent evidence to the contrary presented, and the presumption disappears when there is competent evidence adduced on appeal to the contrary. From that point forward, the reasonableness of the valuation fixed by the board of equalization becomes one of fact based upon all the evidence presented. The burden of showing such valuation to be unreasonable rests upon the taxpayer on appeal from the action of the board."
- 12. The order, decision, determination or action appealed from shall be affirmed unless evidence is adduced establishing that the order, decision, determination, or action was unreasonable or arbitrary.⁵
- 13. Proof that the order, decision, determination, or action was unreasonable or arbitrary must be made by clear and convincing evidence.⁶
- 14. A Taxpayer must introduce competent evidence of actual value of the Subject Property in order to successfully claim that the Subject Property is overvalued.⁷
- 15. The Commission's Decision and Order shall include findings of fact and conclusions of law.⁸

Findings of Fact & Conclusions of Law

- 16. The Taxpayer alleged that the assessed value of the Subject Property was greater than its actual value and that the assessed value of the Subject Property was not equalized with other comparable properties on a per square foot basis.
- 17. The Taxpayer presented one property which recently sold in the same neighborhood as the Subject Property and alleged that this sale price demonstrated the market value of the Subject Property.
- 18. The Taxpayer presented three properties located in the same neighborhood as the Subject Property which were assessed at lower amounts per square foot than the Subject Property to demonstrate a lack of equalization with other comparable properties.
- 19. Comparable properties share similar use (residential, commercial/industrial, or agricultural), physical characteristics (size, shape, and topography), and location.⁹
- 20. "A sales comparison adjustment is made to account (in dollars or a percentage) for a specific difference between the subject property and a comparable property. As the

- comparable is made more like the subject, its price is brought closer to the subject's unknown value."¹⁰
- 21. The County Board presented the Property Record Files (PRF) for the Subject Property as well as information regarding the qualified sales that occurred in the economic area of the Subject Property used in determining the value attributed to each of the characteristics of residential properties in the area, including the Subject Property, to support the per square foot assessed values of the Subject Property and the other properties presented.
- 22. The Taxpayer did not present the PRF for any of the properties presented for valuation or equalization purposes. Without the details contained in the PRF, the Commission is unable to determine the contributions to value of the various amenities or features of the properties such as size, quality, condition, fireplaces, etc.¹¹
- 23. The Taxpayer produced information from the County Assessor's website regarding each of the four properties.
- 24. The information from the County Assessor's website shows that the sold property has a lower quality rating, a much smaller lot, and no brick veneer.
- 25. The information from the County Assessor's web site shows that the three properties presented for equalization purposes all have lower quality ratings and smaller lots than the Subject Property. Each has different features such as no brick veneer, fewer fireplaces, etc., which would indicate that their per square foot assessed values should be less than the Subject Property.
- 26. The Taxpayer has not produced competent evidence that the County Board failed to faithfully perform its duties and to act on sufficient competent evidence to justify its actions.
- 27. The Taxpayer has not adduced clear and convincing evidence that the determination of the County Board is arbitrary or unreasonable and the decisions of the County Board should be affirmed.

ORDER

IT IS ORDERED THAT:

- 1. The Decision of the County Board of Equalization determining the taxable value of the Subject Property for tax year 2017 is affirmed.
- 2. The taxable value of the Subject Property for tax year 2017 is:
