Decision and Order
Affirming the Decision of the
Douglas County Board of Equalization

Background

1. The Subject Property is a residential parcel, with a legal description of Linwood Park Lot 18 Block 1 37.5x130 Omaha, Nebraska.
2. The Douglas County Assessor (the County Assessor) assessed the Subject Property at \$33,500 for tax year 2018 and \$39,200 for tax year 2019.
3. Bel Fury Investments Group, LLC (the Taxpayer) protested these values to the Douglas County Board of Equalization (the County Board) and requested assessed values of \$26,900 for tax year 2018 and \$26,300 for tax year 2019.
4. The County Board determined that the taxable value of the Subject Property was \$33,500 for tax year 2018 and \$39,200 for tax year 2019.
5. The Taxpayer appealed the determinations of the County Board to the Tax Equalization and Review Commission (the Commission).
6. A Single Commissioner hearing was held on August 12, 2020, at the Tax Equalization and Review Commission Hearing Room, Sixth Floor, Nebraska State Office Building, 301 Centennial Mall South, Lincoln, Nebraska, before Commissioner James D. Kuhn.
7. Arielle Bloemer, legal counsel, and Scott W. Bloemer, Member, were present at the hearing for the Taxpayer.
8. Kurt Skradis (the Appraiser), was present at the hearing for the County Board.

Applicable Law

9. All real property in Nebraska subject to taxation shall be assessed as of the effective date of January 1.¹
10. The Commission’s review of a determination of the County Board of Equalization is de novo.²
11. When considering an appeal a presumption exists that the “board of equalization has faithfully performed its official duties in making an assessment and has acted upon

sufficient competent evidence to justify its action.”³ That presumption “remains until there is competent evidence to the contrary presented, and the presumption disappears when there is competent evidence adduced on appeal to the contrary. From that point forward, the reasonableness of the valuation fixed by the board of equalization becomes one of fact based upon all the evidence presented. The burden of showing such valuation to be unreasonable rests upon the taxpayer on appeal from the action of the board.”⁴

12. The order, decision, determination or action appealed from shall be affirmed unless evidence is adduced establishing that the order, decision, determination, or action was unreasonable or arbitrary.⁵
13. Proof that the order, decision, determination, or action was unreasonable or arbitrary must be made by clear and convincing evidence.⁶
14. A taxpayer must introduce competent evidence of actual value of the Subject Property in order to successfully claim that the Subject Property is overvalued.⁷
15. The Commission’s Decision and Order shall include findings of fact and conclusions of law.⁸

Findings of Fact & Conclusions of Law

16. The Taxpayer asserted that the Subject Property is being over assessed as evidenced by his comparable properties and comparable property sales. The Taxpayer contends the adjusted price per square foot of the comparable properties is lower than the price per square foot of the Subject Property.
17. The Taxpayer provided a spreadsheet with the comparable properties with “market” adjustments for item differences between the comparables and the Subject Property. Although Bloemer may have knowledge of the Omaha real estate market, he is not a trained appraiser and none of the adjustments can be quantified by supporting evidence.
18. The Appraiser stated the comparable sales were invalid sales for equalization purposes and that the comparable properties were in different assessment neighborhoods with different neighborhood adjustments and would not be considered comparable.
19. The Taxpayer provided a Property Evaluation Report done by Connie Watson on June 23, 2020 that estimated \$22,200 in repairs to the siding, roof, gutters, foundation, exterior doors and driveway were needed. The Appraiser stated the Subject Property is rated “fair” condition which takes into consideration that much repair is needed and deferred maintenance is obvious.

20. The Taxpayer has not produced competent evidence that the County Board failed to faithfully perform its duties and to act on sufficient competent evidence to justify its actions.
21. The Taxpayer has not adduced clear and convincing evidence that the determinations of the County Board are arbitrary or unreasonable and the decisions of the County Board should be affirmed.

ORDER

IT IS ORDERED THAT:

1. The Decisions of the County Board of Equalization determining the taxable value of the Subject Property for tax years 2018 and 2019 are affirmed.
2. The taxable value of the Subject Property for tax year 2018 is: **\$33,500**.
3. The taxable value of the Subject Property for tax year 2019 is: **\$39,200**.
4. This Decision and Order, if no further action is taken, shall be certified to the Douglas County Treasurer and the Douglas County Assessor, pursuant to Neb. Rev. Stat. § 77-5018 (Reissue 2018).
5. Any request for relief, by any party, which is not specifically provided for by this Decision and Order is denied.
6. Each Party is to bear its own costs in this proceeding.
7. This Decision and Order shall only be applicable to tax years 2018 and 2019.
8. This Decision and Order is effective on August 20, 2021.
