Background

1. The Subject Property is a residential parcel improved with a 1,614 square foot two story residence, with a legal description of: Minne Lusa Lot 10 Block 8 44 X 120, Omaha, Douglas County, Nebraska.
2. The Douglas County Assessor (the County Assessor) assessed the Subject Property at \$74,600 for tax year 2018, \$84,000 for tax year 2019 and \$88,300 for tax year 2020.
3. Bel Fury Investments Group LLC (the Taxpayer) protested these values to the Douglas County Board of Equalization (the County Board) and requested assessed values of \$38,000 for tax year 2018, \$44,400 for tax year 2019 and \$28,100 for tax year 2020.
4. The County Board determined that the taxable value of the Subject Property was \$74,600 for tax year 2018, \$84,000 for tax year 2019 and \$88,300 for tax year 2020.
5. The Taxpayer appealed the determinations of the County Board to the Tax Equalization and Review Commission (the Commission).
6. A Single Commissioner hearing was held on May 24, 2021, at Omaha State Office Building, 1313 Farnam, Room 227, Omaha, Nebraska, before Commissioner Steven Keetle.
7. Arielle Bloemer, legal counsel, and Scott W. Bloemer were present at the hearing for the Taxpayer.
8. Scott Barnes and Kurt Skradis with the Douglas County Assessor/Register of Deeds Office (the County Appraisers) were present for the County Board.

Applicable Law

9. All real property in Nebraska subject to taxation shall be assessed as of the effective date of January 1.<sup>1</sup>
10. The Commission's review of a determination of the County Board of Equalization is de novo.<sup>2</sup>

11. When considering an appeal a presumption exists that the “board of equalization has faithfully performed its official duties in making an assessment and has acted upon sufficient competent evidence to justify its action.”<sup>3</sup> That presumption “remains until there is competent evidence to the contrary presented, and the presumption disappears when there is competent evidence adduced on appeal to the contrary. From that point forward, the reasonableness of the valuation fixed by the board of equalization becomes one of fact based upon all the evidence presented. The burden of showing such valuation to be unreasonable rests upon the taxpayer on appeal from the action of the board.”<sup>4</sup>
12. The order, decision, determination or action appealed from shall be affirmed unless evidence is adduced establishing that the order, decision, determination, or action was unreasonable or arbitrary.<sup>5</sup>
13. Proof that the order, decision, determination, or action was unreasonable or arbitrary must be made by clear and convincing evidence.<sup>6</sup>
14. A Taxpayer must introduce competent evidence of actual value of the Subject Property in order to successfully claim that the Subject Property is overvalued.<sup>7</sup>
15. The Commission’s Decision and Order shall include findings of fact and conclusions of law.<sup>8</sup>

#### Findings of Fact & Conclusions of Law

16. The Taxpayer alleged that the value of the Subject Property was negatively impacted by the condition of the property.
17. The Taxpayer stated that the Subject Property had been occupied by an individual who had agreed to rehabilitate the Subject Property and live in the Subject Property on a rent-to-own basis, but that any work that was done under this agreement was a detriment rather than an improvement to the Subject Property.
18. The Taxpayer presented photographs of the interior and exterior of the Subject Property which the Taxpayer stated reflected the condition of the Subject Property on each of the assessment dates at issue in these appeals.
19. The Taxpayer presented estimates for the repair and remodeling of the Subject Property in the amounts of \$68,528 and \$80,605, and an insurance estimate for the repair of hail damage to the roof, gutters, downspouts and window wraps.

20. The County Board presented the 2018, 2019, and 2020 Property Record File (PRF) for the Subject Property and information regarding recent valid sales for each tax year.
21. The PRF shows that the market area in which the Subject Property is located was reappraised for tax years 2018, 2019, and 2020.
22. The PRF for the Subject Property shows that in 2018, 2019, and 2020 it had a condition rating of fair.
23. The County Appraisers stated that after reviewing the information presented to the Commission, including the photographs and estimates provided by the Taxpayer, the condition rating of fair took into account the condition of the Subject Property as of the assessment dates.
24. The County Appraisers stated that the exterior of the Subject Property had been rehabilitated in 2014 and that if the work indicated in either of the estimates was completed, the condition rating would likely be raised to good or very good.
25. The Taxpayer has not presented information to demonstrate that the condition rating of fair for the Subject Property as shown on the PRF was arbitrary or unreasonable.
26. The Taxpayer alleged that the per square foot assessed value of the Subject Property was not equalized with comparable properties for tax years 2018, 2019, and 2020.
27. The Taxpayer notes that the Nebraska Court of Appeals held in *Scribante* that “To set the valuation of similarly situated property, i.e. comparables, at materially different levels, i.e., value per square foot, is by definition, unreasonable and arbitrary, under the Nebraska Constitution.”<sup>9</sup>
28. Comparable properties share similar use (residential, commercial industrial, or agricultural), physical characteristics (size, shape, and topography), and location.<sup>10</sup>
29. The Taxpayer presented the PRF of properties located near the Subject Property for tax years 2018, 2019, and 2020.
30. The Taxpayer presented a chart that made adjustments to the value of the comparable properties for each tax year to adjust for differences in the characteristics of the properties. The Taxpayer stated that these adjustments were made based on his experience in the real estate market and the information contained in the PRFs. Although the Taxpayer may have knowledge of the Omaha real estate market, he is not a trained appraiser and none of the adjustments can be quantified by supporting evidence.
31. The County Appraisers stated that the Taxpayer’s comparable properties are all located in different market areas than the Subject Property and would not be comparable due to different market factors in each market area.
32. The Taxpayer alleges that the market areas determined by the County Assessor are arbitrary or unreasonable.
33. The Taxpayer did not present information to demonstrate that the market areas utilized by the County Assessor are arbitrary or unreasonable.

34. The Commission finds that the properties presented by the Taxpayer as comparable properties are not comparable to the Subject Property.
35. The Taxpayer has not demonstrated that the valuation of similarly situated properties were set at materially different levels entitling the Subject Property to a reduction assessed value under the court's determination in *Scribante*.
36. The Taxpayer has not produced competent evidence that the County Board failed to faithfully perform its duties and to act on sufficient competent evidence to justify its actions.
37. The Taxpayer has not adduced clear and convincing evidence that the determinations of the County Board are arbitrary or unreasonable and the decisions of the County Board should be affirmed.

ORDER

IT IS ORDERED THAT:

1. The Decisions of the County Board of Equalization determining the taxable value of the Subject Property for tax years 2018, 2019, and 2020 are affirmed.
2. The taxable value of the Subject Property for tax year 2018 is:

5. The taxable value of the Subject Property for tax year 2020 is:

6. This Decision and Order, if no further action is taken, shall be certified to the Douglas County Treasurer and the Douglas County Assessor, pursuant to Neb. Rev. Stat. § 77-5018 (Reissue 2018).
7. Any request for relief, by any party, which is not specifically provided for by this Decision and Order is denied.
8. Each party is to bear its own costs in this proceeding.
9. This Decision and Order shall only be applicable to tax years 2018, 2019 and 2020.

10. This Decision and Order is effective on February 18, 2022.
