**Information for Statewide Equalization 2022**  
**Survey of County Assessors/Software Providers for Administrative Systems**

**1) Computer system limitation on decimal places for % change for equalization:**

**MIPS Inc. PC System V2:** Limited to 2 places to the right of a decimal point, for example .1111 or 11.11%. Values may be rounded to the nearest \$1 or \$5.

**Aumentum Tech/TerraScan:** No limit on decimal place % change. Values can be rounded to nearest \$1, \$5, \$10, etc., depending on county's individual choice on settings.

**Aumentum/T-2:** Limited to 2 places to the right of the decimal point, for example .1111 or 11.11%. Values are rounded to the nearest \$5.

**Tyler Technologies/Orion:** No limit on decimal place percentage change. Values can be rounded to nearest \$1, \$5, \$10, etc.

**Vanguard Appraisals, Inc.:** Limited to 2 places to the right of a decimal point, for example .1111 or 11.11%.

**Douglas County:** Colorado CustomWare/RealWare is limited to 2 places to the right of a decimal point, for example .1111 or 11.11%.

**E-Ring, Inc.:** No limit on decimal place % change. Values can be rounded to nearest \$1, \$5, \$10, etc., depending on county's individual choice on settings.

**2) Other than identifying correct class or subclass of property, are there any other computer system limitations or comments:**

**MIPS Inc. PC System or PC System V2:** Only limit depends on information kept in the administrative system by each specific county.

**Aumentum Technologies/TerraScan:** The land value, improvement value, and outbuilding value can all be adjusted separately, but anything beyond that is not easily achieved (e.g., increasing the residence only as opposed to the total residential improvement value).

**Aumentum Technologies/T-2:** No other comments regarding computer system limitations.

**Tyler Technologies/Orion:** No other comments regarding computer system limitations.
